



## Prenatal Postpartum Visit (PPC)

The percentage of deliveries of live births between Oct. 8 of the prior year and Oct. 7 of the measurement year. For these women, the measure assesses the following facets of prenatal and postpartum care.

- **Timeliness of Prenatal Care:** The percentage of deliveries that received a prenatal care visit as a patient in the first trimester on or before the enrollment start date on or within 42 days of enrollment in the organization. Prenatal care visits include visits to an OB/GYN or other prenatal care practitioner or PCP. For visits to the PCP, a diagnosis of pregnancy must be present.
- Postpartum visit includes a visit to an OB/GYN practitioner or midwife, family practitioner or other PCP on or between 7 and 84 days after delivery.

Physical and mental conditions that can lead to complications may start before, during, or after pregnancy. It's very important for anyone who may become pregnant to get health care before, during, and after pregnancy to lower the risk of pregnancy complications.

### Acceptable Documentation for PPC (Prenatal visit):

- A basic physical OB exam with any of the following: fetal heart tones, pelvic exam, fundal height measurement. Use of standardized prenatal flow sheet is acceptable.
- Evidence that prenatal care procedure was performed: OB panel screening test, TORCH antibody panel alone or rubella antibody test/titer with an Rh incompatibility (ANO/Rh) blood typing, or Ultrasound.
- Documentation of LMP, EDD or gestational age in conjunction with either of the following: Prenatal risk assessment and counseling education and/or Complete obstetrical history.



### Acceptable Documentation for for PPC (Postpartum visit):

- Pelvis Exam
- Evaluation of weight, BP, breasts (breast feeding is acceptable for the “evaluation of breasts” component), and abdomen.
- Notation of postpartum care ex; postpartum care, PP care, PP check, 6-week check
- Perineal or cesarean incision/wound check
- Screening for depression, anxiety, tobacco use, substance use disorder or preexisting mental health disorders.
- Glucose screening for women with gestational diabetes
- Documentation of any of the following topics: Infant care, Resumption of intercourse, birth spacing, family planning, sleep/fatigue, resumption of physical activity and attainment of healthy weight

### Unacceptable Documentation for for PPC (Postpartum visit):

- A PAP test does not meet criteria for prenatal care

### Tips and Best Practices to Close PPC Care Gap:

- Schedule your patient for a postpartum visit within 7 to 84 days from delivery.
- Stress and educate patients on the importance of the prenatal/initial visit.
