What services are available?

Making your health a priority is an important step towards preventing disease and illness. If you are a MO HealthNet (Missouri Medicaid) participant, preventative services are included in your benefits and available at no cost. Examples of services include:

Smoking Cessation

Get the help you need to guit smoking with free nicotine gum or patches.

Diabetes Prevention Program

Helps prevent or delay the progression of type-2 diabetes for participants 21 and older.

Healthy Children & Youth Program

Regular healthcare screenings and preventative care for children and youth.

Maternal/Infant Care Management

Helps pregnant mothers and their newborns receive care during and after pregnancy.

Immunizations

Protects children and adults from getting and spreading preventable diseases.

Obesity Services

Prevention, assessment, and treatment of obesity to improve overall health outcomes.

Health Homes

Care management for those with two or more qualifying chronic health conditions.

Oral Health

Preventative services such as cleanings, fluoride treatments, and dental sealants.

Non-Emergency Medical Transportation is available to participants for scheduled appointments.

Discrimination & Civil Rights
