## All Well-Child Visits

**Must include the following:** Documentation of a visit with an acceptable provider type, the date of the visit, and services to validate a well-child visit was performed.

<b>(WCV) Child and Adolescent Well-Care Visits (3–21 years of age)</b> <sup>1,2</sup>	99382–99385, 99392–99395, S0302, S0610, S0612, S0613, Z00.00, Z00.01, Z00.121, Z00.129, Z00.2, Z00.3, Z01.411, Z01.419, Z02.5, Z02.84, Z76, Z76.2	One or more comprehensive well-care visits with a primary care provider (PCP) or obstetrician/gynecologist (OB/GYN) within the measurement year. Visits occurring anytime in the measurement year, including prior to or after the patient’s birthday, close the gap.

<b>(CWP) Appropriate Testing for Pharyngitis</b> <sup>1,2</sup>	<p><b>Group A Strep Test:</b> 87070, 87071, 87081, 87430, 87650–87652, 87880</p>	<p>For episodes involving persons <b>3 years of age and older</b>:</p> <ul style="list-style-type: none"> <li>• <b>Establish</b> a <i>pharyngitis</i> diagnosis</li> <li>• <b>Test</b> for <i>group A streptococcus (strep)</i></li> <li>• <b>Treat</b> with antibiotics <i>only if group A strep is detected</i></li> </ul> <p><b>Note:</b> Perform a group A strep test <b>before</b> prescribing or dispensing antibiotics.</p>
	<p><b>Pharyngitis:</b> J02.0, J02.8, J02.9, J03.00, J03.01, J03.80, J03.81, J03.90, J03.91</p>

<b>(WCC) Weight Assessment and Counseling for Nutrition and Physical Activity for Children/Adolescents (3–17 years of age)</b> <sup>1,2</sup>	<p><b>BMI:</b> Z68.51, Z68.52, Z68.53, Z68.54, Z68.55, Z68.56</p> <p><b>Nutrition Counseling:</b> 97802–97804, G0270, G0271, G0447, S9449, S9452, S9470, Z71.3</p> <p><b>Physical Activity (PA):</b> G0447, S9451, Z02.5, Z71.82</p>	Can be completed during a PCP or OB/GYN visit during the measurement year. Documentation must include height, weight, body mass index (BMI) percentile, nutrition behaviors and counseling, and current physical activity behaviors and counseling or guidance.
