Did you know that you could get free, same-day expert child psychiatry phone consultation through the Missouri Child Psychiatry Access Project (MO-CPAP)?

**By participating in the MO-CPAP Program, primary care providers (PCP) receive access to:**

- Same-day telephonic consultations with a child and adolescent psychiatrist within 30 minutes of a call or scheduled at your convenience. Child and adolescent psychiatrists are available Monday-Friday, 10 a.m.-6 p.m. (except major holidays) to provide behavioral health consultation, including diagnostic issues and medication management.
- 24/7 follow-up care coordination through Behavior Health Response to help primary care providers connect their patients with referral services to community resources, behavior intervention options, or follow up services.

#### **How does a MO-CPAP consultation work?**

- When a child is identified by the PCP to have mild to moderate behavior health (BH) care needs or if the PSP has a BH question, PCP will call MO-CPAP at 844-538-2279
- MO-CPAP will assist with:
  - Follow up BH care coordination or community referrals
  - Answering questions about diagnostic tests, medications, and treatment plans
  - Consultation with an available child and adolescent psychiatrist during hours listed above
  - Ongoing BH educational opportunities

#### **How does your patient benefit?**

The child maintains medical home and receives treatment for mild to moderate BH needs.
