Annual Dental Visit (ADV)

What We Measure:

The percentage of patients 2–20 years of age who had at least one dental visit during the measurement year Change this to January 1–December 31

- Services must be performed by a dental practitioner (DDS, DMD, and certified and licensed dental hygienists).
- For many one-year-olds, visits will be counted because the specification includes children whose second birthday occurs during the measurement year.
- Tele dentistry services utilized for dental emergencies will satisfy the ADV measure.

Why it Matters:

- Healthy oral habits are linked to overall health. Serious dental health conditions like root canals, periodontal disease, and gingivitis often coincide with increased risk of cardiovascular disease, anemia, and other health conditions.
- Preventive oral healthcare helps our patients avoid cavities, gum disease, and wearing of their teeth's enamel.

Tips and Best Practices for Improving ADV:

 Advise patients/parents that patients may be eligible to receive a gift card for going to the dentist for a cleaning. This can encourage patients to keep appointments once they are referred and scheduled with a dentist.

Lines of Business Affected: Medicaid



- Provide local primary care practitioners with your practice's contact information for easy patient referral.
- Encourage new patients to establish a dental home with your practice to ensure good routine oral healthcare and follow ups.
- Remind expectant mothers to make dental appointments for the baby either at the eruption of first tooth or by the age of one.
- Send parents reminders every six months to schedule for periodic exams, prophylaxis (cleanings), and fluoride treatments.
- Apply sealants on the first molars to prevent tooth decay.
